1. INTRODUCTION

The Circular Bio-based Europe Joint Undertaking (hereafter ‘the CBE JU’) is committed to protect your personal data and to respect your privacy. The CBE JU collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This privacy statement explains the reason for the processing of your personal data in the context of CBE JU Stakeholder Forum 2023. It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to the processing operation of the event registration and organisation, undertaken by CBE JU, is presented below.

2. WHY AND HOW WE PROCESS YOUR PERSONAL DATA?

Purpose of the processing operation: The CBE JU collects and further processes your personal data to provide you with information about the CBE JU Stakeholder Forum 2023 (before, during and after) and to process your application for participation in the event.

Audio-visual recording of the moderators, speakers, organisers and participants, as well as photographs of the speakers and panoramic photographs of participants and organisers will be taken and published in the context of the CBE JU Stakeholder Forum 2023 on the CBE JU external communication channels.

The audience or non-speaker participants could be photographed individually or in groups, as well as appear on panoramic photographs.

Participants who do not wish to be part of the above recording/publishing activities have the possibility to object sending an email to events@cbe.europa.eu. These participants will be required to sit in the back rows in the audience and will be identified by a tag on the badge during social activities.

Your personal data will not be used for any automated decision-making including profiling.

3. ON WHAT LEGAL GROUND(S) DO WE PROCESS YOUR PERSONAL DATA?

The processing operations on personal data, linked to the organisation, management, follow-up and promotion of the CBE JU Stakeholder Forum 2023 (*including* photos, audio-visual recording) are necessary for the management and functioning of the CBE JU, as mandated by the Treaties. Those provisions are in particular, the performance of a task carried out in the public interest and the data subject has given consent to the processing of his or her personal data for one or more specific purposes (articles 5.1 (a) and (d) of Regulation 2018/1725).

Specific legal basis: - Article 2 c) n) and o) of the Statutes annexed to Council Regulation (EU) No 560/2014 of 6 May 2014 establishing the CBE JU and Article 11 of the Treaty on European Union and Article 15 of the Treaty on the Functioning of the European Union. Consequently, those processing operations are lawful under Article 5(1)(a) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body).

Your consent is required for:

- the processing of your personal data relating to your dietary and accessibility requirements;
- the sharing of the CBE JU Stakeholder Forum 2023 participants list containing your name and affiliation with other participants;
- the processing of your personal data for inviting you to future events the data controller may organise;
- the processing of your personal data for managing your subscription to a newsletter of the data controller if you have opted in for it.

If you opt-in, you are giving us your explicit consent under Article 5(1)(d) of Regulation (EU) 2018/1725 to process your personal data for those specific purposes. You can give your consent via a clear affirmative act by ticking the box(es) on the online registration form.

Your consent for these services can be withdrawn at any time:

- for unsubscribing from the newsletter, please click on the unsubscribe button;
- for withdrawing consent that you have provided in order to benefit from other services, please contact the controller of the meeting/event at events@cbe.europa.eu.

4. WHICH PERSONAL DATA DO WE COLLECT AND FURTHER PROCESS?

The following personal data will be processed:

- contact details (title, first name(s), last name(s), job title, e-mail address, organisation name, type and sector, country of work);
- dietary requests (if any) or specific access requirements.

5. HOW LONG DO WE KEEP YOUR PERSONAL DATA?

The Data Controller only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing.

For each of the categories of personal data that is processed, please find below the retention details and the reference to the relevant record of processing:

- All personal data related to the organisation and management of the CBE JU Stakeholder Forum 2023 (this includes the information given during the registration, before, during or after the event) will be deleted **five years** after the last action in relation to the event.
- Sensitive personal data relating to dietary requests will be deleted as soon as they are no longer necessary for the purpose for which they have been collected in the framework of the CBE JU Stakeholder Forum 2023, but no later than within **1 month** after the end of the event.
- The audio-visual recording of the CBE JU Stakeholder Forum 2023 will be kept for **5 years** after the event before being deleted.

- Personal data shared with the controller for future mailing purposes (e.g., for receiving newsletters or invitations to similar events) are processed in line with the Record of Processing, DPO-4-03.
- Selected service providers for organisational purposes (such as caterers or event management organisations) are contractually bound to process personal data on behalf of and in line with the instructions of the data controller, keep confidential any data they process and protect it from unauthorised access, use and retention.

6. HOW DO WE PROTECT AND SAFEGUARD YOUR PERSONAL DATA?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of CBE JU. All processing operations are carried out pursuant to [Commission Decision \(EU, Euratom\) 2017/46](#) of 10 January 2017 on the security of communication and information systems in the European Commission.

The CBE JU's contractors are bound by a specific contractual clause for any processing operations of your personal data on behalf of CBE JU, and by the confidentiality obligations deriving from the General Data Protection Regulation ('GDPR' - [Regulation \(EU\) 2016/679](#)).

In order to protect your personal data, CBE JU have put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

7. WHO HAS ACCESS TO YOUR PERSONAL DATA AND TO WHOM IS IT DISCLOSED?

Access to your personal data is provided to CBE JU staff responsible for carrying out this processing operation and to other authorised CBE JU staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

COOKIES

Cookies are short text files stored on a user's device (such as a computer, tablet or phone) by a website. Cookies are used for the technical functioning of a website (functional cookies) or for gathering statistics (analytical cookies).

The registration for the CBE JU Stakeholder Forum 2023 takes place via a website set up by CBE JU contractor. The cookies employed by the contractor on the registrant's device for that purpose will comply with Regulation (EU)2018/1725.

THIRD PARTY IT TOOLS, INCLUDING SOCIAL MEDIA

We use third party IT tools to inform about and promote the CBE JU Stakeholder Forum 2023 through widely used communication channels, including the social media.

You can watch our videos, which we also upload on our website, LinkedIn, YouTube and X accounts, as well as follow links from our website.

In order to protect your privacy, our use of third-party IT tools to connect to those services does not set cookies when our website pages are loaded on your computer (or other devices), nor are you immediately redirected to those social media or other websites. Only in the event that you click on a button or “play” on a video to watch it, a cookie of the social media company concerned will be installed on your device. If you do not click on any social media buttons or videos, no cookies will be installed on your device by third parties.

In order to view such third-party content on our websites, a message will alert you that you need to accept those third parties’ specific Terms and Conditions, including their cookie policies, over which CBE JU has no control.

We recommend that users read the relevant privacy policies of the third-party IT tools carefully before using them. These explain each company’s policy of personal data collection and further processing, their use of data, users’ rights and the ways in which users can protect their privacy when using those services.

The use of a third-party IT tool does not in any way imply that the CBE JU endorses them or their privacy policies. In the event that one or more third party IT tools are occasionally unavailable, we accept no responsibility for lack of service due to their downtime.

8. WHAT ARE YOUR RIGHTS AND HOW CAN YOU EXERCISE THEM?

You have specific rights as a ‘data subject’ under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) of Regulation (EU) 2018/1725 on grounds relating to your particular situation.

You have consented to provide your personal data to the data controller for the present processing operation. You can withdraw your consent at any time by notifying the data controller events@cbe.europa.eu. The withdrawal of your consent will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

You can exercise your rights by contacting the data controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given in the section 9.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified in the section 10) in your request.
